

Ashville 4th of July Celebration Commercial / Direct Sales – 2017 Exhibitor Contract and Show Rules

Where: Ashville Community Park grounds
Festival Dates: June 30 – July 4
Show Dates/Hours: June 30 - 5:00-11:00pm
July 1 & 2- Noon-11:00pm
July 3 - 5:00pm-11:00pm
July 4 - 11:00am-11:00pm
Cost: \$250 for 1st 10x10 then \$125 per additional space
Electric is included

Vendors will need to supply their own shelter for outside setup. Vendors using trailers will be charged according to the length of the space used in 10 foot increments.

Booth Location will be provided upon arrival for setup and will be marked with the vendor name for easy identification

Sales Rules

1. All vendors are required to submit photos of products to be sold (photos will not be returned)
2. The event committee reserves the right to refuse any item(s) they deemed to be of poor quality or not in the interest of the public or any item that may unfavorably reflect on the Ashville 4th of July Celebration
3. The event committee reserves the right to refuse any contract
4. All items must be contained in your assigned space.
5. All vendors must be completely set up and all vehicles out of the festival area no later than 1 HOUR BEFORE FESTIVAL OPENING. No vehicles may enter the festival area at any time during festival operating hours (No Exceptions – this WILL be enforced)
6. EXCLUSIONS – There shall be no sale of any counterfeit items, weapons of any kind (knives, stars, projectiles, etc.), any items which include profanity, suggestive sexual or immoral ideas as deemed by the committee or the sale of any food or beverages (of any type) for human consumption
7. Vendors must dispose of trash from their space(s) in the dumpsters. Trash should not be placed in the festival barrels or left around the vendor site
8. The Ashville 4th of July Celebration is held rain or shine. Vendors must remain open during the entire festival operating hours unless permitted by the event committee
9. Vendors are prohibited from loud music, noise and “hawking,” whether inside or outside the assigned space
10. Vendors are prohibited from any strolling sales.
11. All booths are required to have an ABC fire extinguisher
12. The vendors must supply their own tables, chairs, covers, backdrops, displays and extension cords (100ft). The festival committee will provide a single 15-amp electric outlet
13. All vendors must carry commercial general liability insurance on an "occurrence" basis with liability limits in the amounts of one hundred thousand dollars (\$100,000.00) or more per occurrence covering personal injury, bodily injury and property damage. Vendors must provide proof of such insurance coverage by June 15, 2017
14. All tents and canopies must have a label with certification that it is fire retardant (compliant with Ohio Fire Code Chapter 24)
15. No generators, air conditioners, open flames, or loud speakers permitted. Fans are permitted
16. Overnight security is NOT provided or contracted by the Ashville Community Men’s Club / Ashville 4th of July Celebration
17. Pets, other than service animals, are not permitted
18. Ashville Community Men’s Club / Ashville 4th of July Celebration is not responsible for any loss, damage, liability or property damage
19. Any vendor issuing a bad check will be charged a \$30.00 fee and will no longer be permitted at the event
20. NO CAMPING FACILITIES ARE AVAILABLE

Vendors refusing to abide by these rules will be ejected from all spaces.

Payment: Make checks payable to Ashville 4th of July Celebration (note "Arts & Crafts" on the memo line)
No refunds will be given. Payments will only be returned if no space is available. Your cancelled check is your receipt. All signed contracts MUST have full payment included to be accepted.

Deadline: Applications and product photos must be received by May 15
Selected participants will be notified by May 30
