

# Ashville 4<sup>th</sup> of July Celebration Arts and Crafts Show

## Exhibitor Contract Rules

Where: Ashville Community Park grounds (covered shelter house and other festival grounds areas)  
Festival Dates: June 30 – July 4  
Show Dates/Hours: June 30 Noon -11:00pm  
July 1, 2 & 3 5:00pm-10:00pm  
July 4 11:00am 11:00pm

Cost: \$125 per 10x10 space (also for 8x12 space in Shelter House) Electric is included

The Shelter House will be filled with homemade arts and crafts first and will fill with other sales/exhibits if Shelter House space permits. Shelter House will be filled before spaces are assigned outside. Shelter House spaces are 10x10 with a few 8x12 center aisle spaces available (2 sides). We will do our best to put vendors in their preferred booth size. Vendors placed outside the Shelter House will need to supply their own 10x10 canopy for outside setup. Vendors using trailers will be charged according to the length of the space used in 10 foot increments.

Booth Location will be provided upon arrival for setup and will be marked with the vendor name for easy identification

### Sales Rules

1. All new vendors are required to submit photos of products to be sold (photos will not be returned)
2. Shelter House space will be filled at the discretion of the event committee with hand crafted arts and crafts given first priority in this space
3. The event committee reserves the right to refuse any item deemed not in the interest of the public or any item that may unfavorably reflect on the Ashville 4<sup>th</sup> of July Celebration
4. The event committee reserves the right to refuse any contract
5. All items must be contained **inside** your assigned space.
6. All vendors must be completely set up and all vehicles out of the festival area no later than 1 HOUR BEFORE FESTIVAL OPENING (No Exceptions – this WILL be enforced)
7. EXCLUSIONS – There shall be no sale of any counterfeit items, weapons of any kind (knives, stars, projectiles, etc.), any items which include profanity, suggestive sexual or immoral ideas as deemed by the committee or the sale of any food or beverages (of any type) for human consumption
8. Vendors must dispose of trash from their space(s) in the dumpsters. Trash should not be placed in the festival barrels or left around the vendor site
9. The Ashville 4<sup>th</sup> of July Celebration is held rain or shine. Vendors must remain open during the entire festival operating hours unless permitted by the event committee
10. Vendors are prohibited from loud music, noise and “hawking,” whether inside or outside the assigned space
11. Vendors are prohibited from strolling sales or sales over the shelter house walls
12. All booths are required to have an ABC fire extinguisher
13. The vendors must supply tables, chairs, covers, backdrops, displays and extension cords (100ft). The festival committee will provide a single 15-amp electric outlet
14. All vendors must carry commercial general liability insurance on an "occurrence" basis with liability limits in the amounts of one hundred thousand dollars (\$100,000.00) or more per occurrence covering personal injury, bodily injury and property damage. Vendors must be able to provide proof of such insurance coverage prior to set up
15. All tents and canopies must have a label with certification that it is fire retardant (compliant with Ohio Fire Code Chapter 24)
16. No generators, air conditioners, open flames, or loud speakers permitted. Fans are permitted
17. Overnight security is NOT provided or contracted by the Ashville Community Men’s Club/Ashville 4<sup>th</sup> of July
18. Pets, other than service animals, are not permitted. Therapy Pets are not service animals.
19. Ashville Community Men’s Club / Ashville 4<sup>th</sup> of July Celebration is not responsible for any loss, damage, liability or property damage
20. Any vendor issuing a bad check will be charged a \$30.00 fee and will no longer be permitted at the event
21. NO CAMPING FACILITIES ARE AVAILABLE

Vendors refusing to abide by these rules will be ejected from all spaces without any refunds.

Payment: Make checks payable to Ashville 4<sup>th</sup> of July Celebration (note "Arts & Crafts" on the memo line)  
**No refunds will be given.** Payments will only be returned if no space is available. Your cancelled check is your receipt. All signed contracts MUST have full payment included to be accepted.

Deadline: Applications and product photos must be received by May 15  
Selected participants will be notified by May 30
